- Entries must be received or postmarked by Saturday, March 5, 2016.**
- Applicant will be notified of your March 13, 2015 audition time on or before Wednesday, March 9, 2016.
- No late entries will be accepted.**
- Applicant must be students currently involved in a high school instrumental music program.
- Applicant must perform a wind or percussion solo for which a band/wind ensemble accompaniment is readily available. (See list attached or found at www.qcwindensemble.org. If the applicant's solo does not have a pre-approved band accompaniment, the applicant must notify Chuck Collins BEFORE Saturday, Feb. 27, 2016.)**
- There is no entry fee for this competition.
- The applicant must perform the same piece in the concert as performed during the audition. Previous first place winners must audition on a different piece.
- Applicant must audition using a piano accompaniment.**
- Applicant must furnish two copies of the solo part for the adjudicators. One of the copies may be a photo-copied reproduction of the original.**
- If Applicant is unable to audition on the Audition Date, the Applicant may submit an UNEDITED, UNCUT video with the above referenced copies of the solo, abiding by all other rules of performance as listed above. The DVD and music must be postmarked by Saturday, March 5, 2016. The music and DVD will be returned through Applicant's Band Director, Private Lesson's Instructor or another means previously determined by communicating in advance with the Solo Competition Coordinator listed below.
